

# Privacy Statement

## Policy

Tourism Plus Foundation is committed to protecting the privacy and accuracy of your personally identifiable information to the extent possible, subject to provisions of state and federal law. Other than as required by laws that guarantee public access to certain types of information, or in response to subpoenas or other legal instruments that authorize disclosure, personally identifiable information is not disclosed without your consent.

## Information Collection and Use

Categories of personally identifiable information collected by [www.tourismplus.org](http://www.tourismplus.org) include: Name, Telephone, & Email address. The personally identifiable information requested by us is to send mailers/emails, download of documents etc. Fields marked with an "\*" are required. By filling in information/s, you grant the authority to Tourism Plus Foundation to maintain this information.

In order to keep you informed of such activities, projects, news and events, symposia and/or special events, we may use personal information collected from our Web site for the purpose of future communication back to online enrollees. Such email notification will be conducted in conformance with Tourism Plus Foundation and by following the practices of anti-spam practices.

Additionally, the Web server [hosting this service] collects, at least temporarily, the following information:[ Internet Protocol (IP) address of computer being used; Web pages requested; referring Web page; browser used; date and time]. This information is collected to monitor your navigation of our Web pages. We may use browser-IP-address information and anonymous-browser history to report information about site accesses and for profiling purposes. This information is generally used to improve Web presentation and utilization. We also may use IP address information for troubleshooting purposes.
